## 1. SITUATION/BACKGROUND

The purpose of this report is to provide narrative to the Month 7 position of NWJCC for the 2025-2026 financial year.

The financial position is reported against the 2025-2026 baselines following approval of the NWJCC Integrated Commissioning Plan by the 7 Health Boards in March 2025.

## 2. ASSESSMENT

The NWJCC financial position for 2025-2026 reported at Month 7 was an overspend to date of £4.4m, with a forecast overspend position of £7.7m against the ICP financial plan.

Risks to the reported position include:

- NICE drugs growth - £1m estimated as being the part-year amount removed from the initial agreed 6% plan to the final agreed 4% plan.
- Reduction of the year-end extrapolation for Paediatric Intensive Care activity in NHS England - £1m
- Winter pressures estimate - £4m (note there are Reserves earmarked towards this of £2.5m)
