1. SITUATION/BACKGROUND

The purpose of this report is to provide narrative to the Month 8 position of NWJCC for the 2025-2026 financial year.

The financial position is reported against the 2025-2026 baselines following approval of the NWJCC Integrated Commissioning Plan by the 7 Health Boards in March 2025.

2. ASSESSMENT

The NWJCC financial position for 2025-2026 reported at Month 8 was an overspend to date of £4.6m, with a forecast overspend position of £7.8m against the ICP financial plan.

Risks to the reported position include:

- NICE drugs growth - £1m estimated as being the part-year amount removed from the initial agreed 6% plan to the final agreed 4% plan.
- Winter pressures estimate - £4m (note there are Reserves earmarked towards this of £1.5m)
