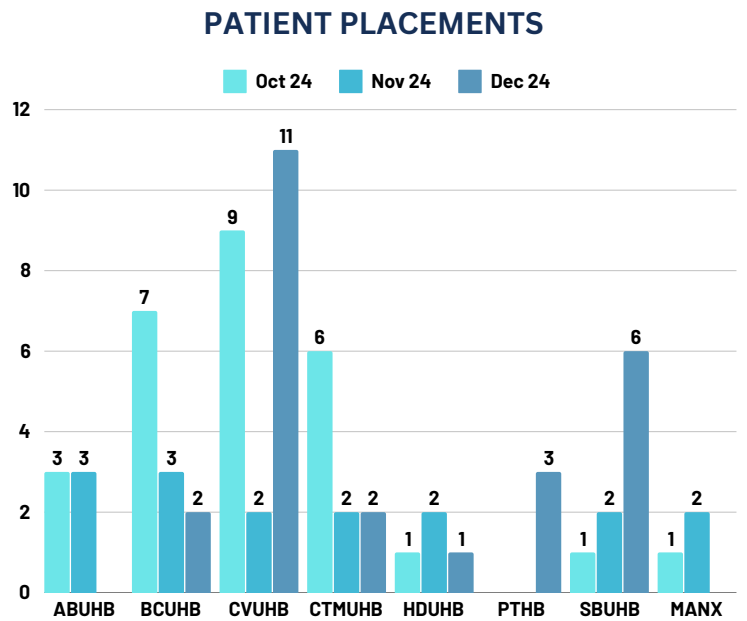

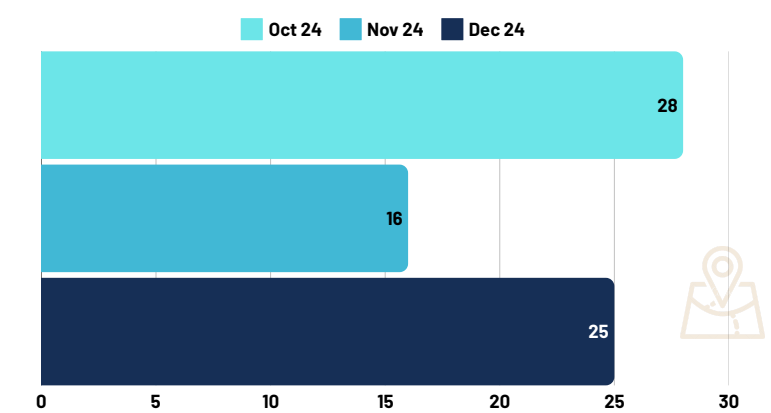

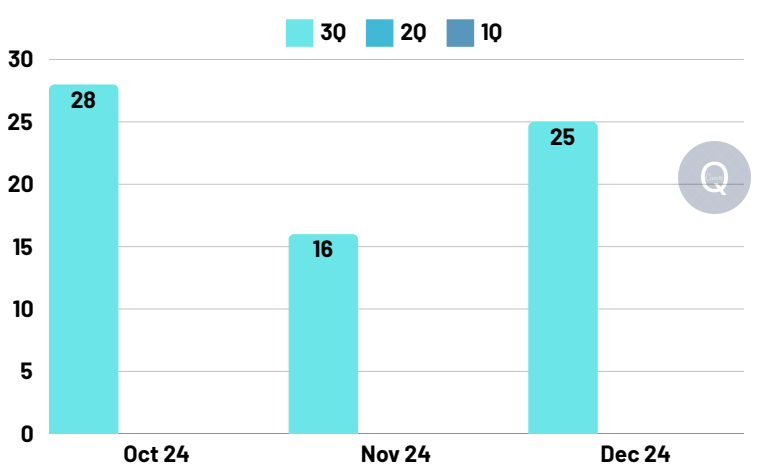
NHS WALES NATIONAL POSITION DECEMBER 2024



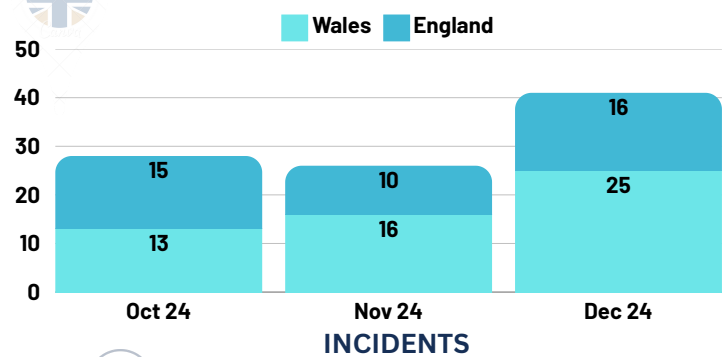
FRAMEWORK PLACEMENTS OCTOBER - DECEMBER 2024



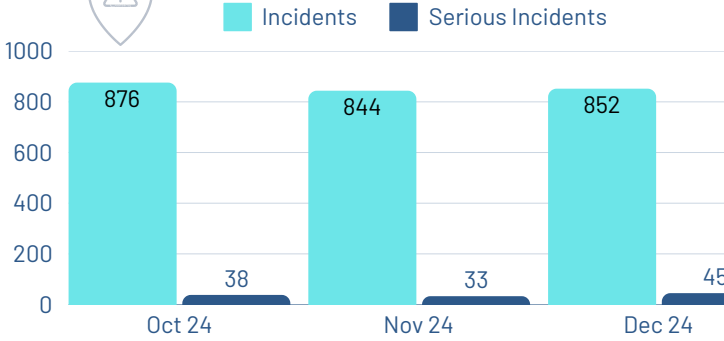
TOTAL QUALITY ASSURANCE RATINGS PLACEMENTS



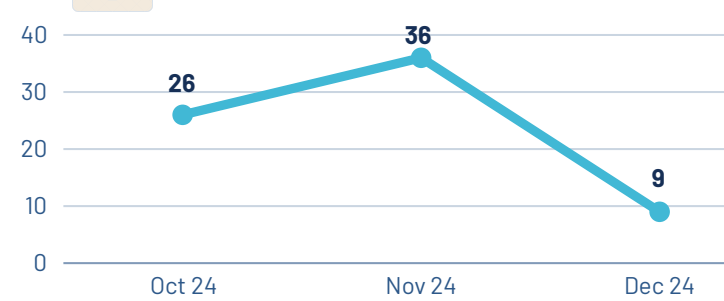

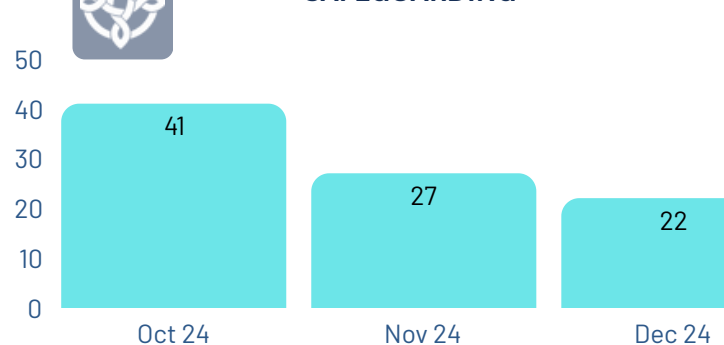

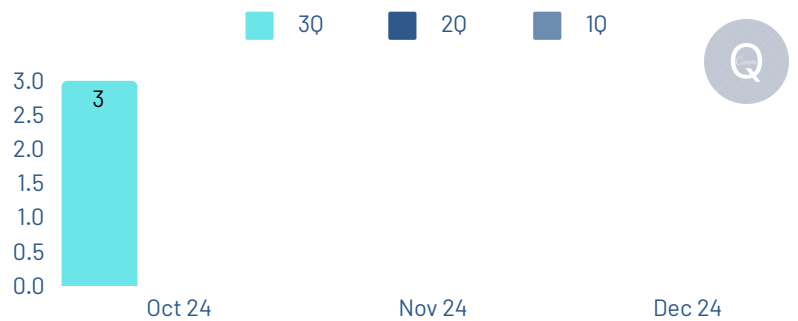
NHS WALES NATIONAL POSITION DECEMBER 2024 PATIENT PLACEMENTS



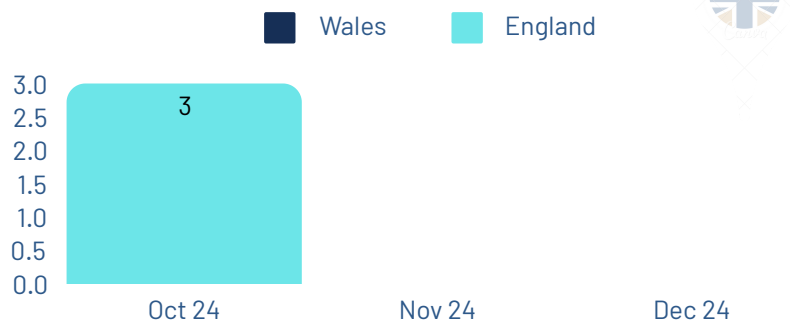
FRAMEWORK PLACEMENTS OCTOBER - DECEMBER 2024



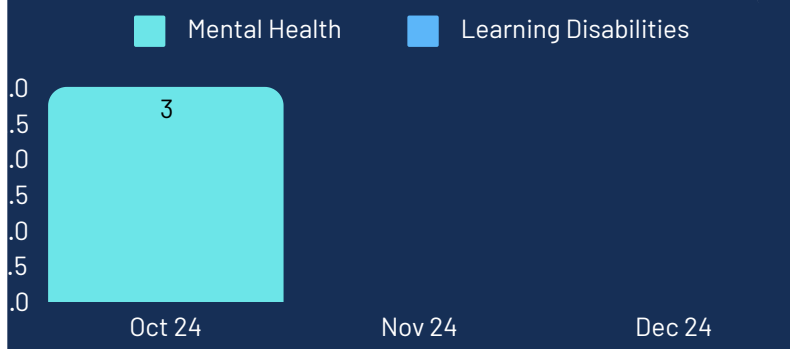
TOTAL QUALITY ASSURANCE RATINGS PLACEMENTS



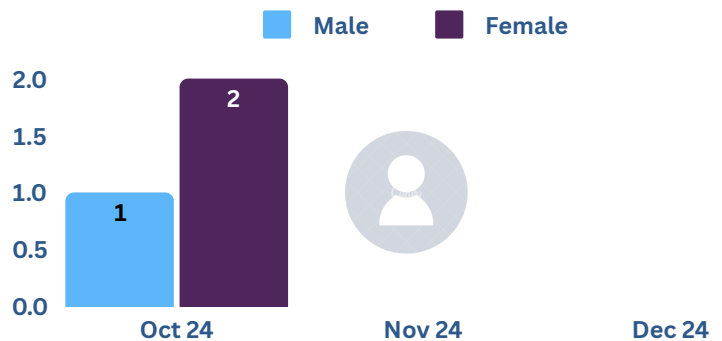
